



## **POLICIES and NON-SMOKING AGREEMENT**

Please read and understand the following rules, regulations and policies in this agreement to comply.

Check-In: After 3:00PM Check-Out: Before 11:00AM

The Bolero Resort & Conference Center is a non-smoking establishment: New Jersey Smoke-Free Air Act (N.J.S.A. 23:3D-55) prohibits smoking in all indoor public areas. VIOLATORS ARE SUBJECT TO FINE of not less than \$250 for the first offense, \$500 for the second offense and \$1,000 for each subsequent offense. Smoking inside is strictly forbidden anywhere and at all times on the premises of the Bolero Resort, including all guest rooms, any and all public areas such as the Office, Elevator, Restaurant, etc. and certain exterior locations.

MARIJUANA, CIGARS AND HOOKAHS ARE PROHIBITED ANYWHERE ON THE PROPERTY. Cigarettes, Vapes and other E-Cigarettes are permitted outside in designated areas equipped with an exterior ash receptacle provided by the resort. Keep doors and windows closed to prevent smoke from entering guest room. No lit substance shall enter any guest rooms at any time. All ashes or butts are to be disposed of only outside in ash receptacles and may not be taken into the rooms at any time. Please be advised that any and all violations of this policy shall result in immediate and permanent eviction from the premises. In no event shall you be entitled to any refund for the unused portion of stay.

- 1. A security deposit in the amount of \$100.00 will be authorized at check-in. This authorization is for both smoking and non-smoking related damages. In the event the damage(s) exceed the \$100 authorization, you will be billed accordingly. Authorizations are released at check-out in accordance with the terms and conditions of this document. The time it takes for an authorization to be removed from your account is up to your bank. Credit cards are recommended over debit cards for authorizations where funds are time sensitive. Please contact your bank for questions on length of hold on authorizations.
- 2. When arriving in your room, check and report all damages to the office immediately; our staff will make note of it. Any unnoted damages can and will be billed to your account.
- 3. At registration, each person occupying the room is to register and show proof of age and legal residence.
- 4. **No visitors** are permitted. Unregistered guests will be considered trespassing.
- 5. **No radios** or stereos are permitted No amplified MUSIC of any kind from speakers, phones or radios.
- 6. NO GLASS of any kind permitted outside your room at any time. This is for everyone's safety. Plastic cups can be provided.
- 7. One car per unit. Parking tag must be displayed at all times. Any unregistered vehicles will be towed at owner's expense.
- 8. Any vulgar language, indecent attire and or behavior inconsistent with public decency is considered reason for eviction.
- 9. Quiet hours are from 12:00AM until 8:00AM. Please be considerate of other guests, especially those with children.
- 10. <u>ALL children</u> must be supervised by an adult at all times. Children under the age of 16 are not permitted in the pool area without an adult over the age of 21 in the pool area at all times (*State of NJ NJAC 8:26-5.2(b)*). No blow up toys, balls or oversized rafts, floats, noodles, etc.
- 11. Any persons under the age of **21** cannot have any alcohol on the premises at any time. Violation is cause for eviction.
- 12. BBQ grilling ALLOWED ONLY IN RECREATIONAL AREA. All other areas are prohibited and will be subject to fine.
- 13. IRONS ARE NOT PERMITTED IN GUEST ROOMS. An iron and ironing board is provided for guests in the Guest Laundry.
- 14. No blow horns, laser lights, water guns, skateboards, beer bongs, or beer pong tables permitted.
- 15. Bicycles are not permitted in guest rooms or along the pool fence. A secure bicycle rack is provided in our parking lot.
